

Full Terms and Conditions:

Lighting as a Service LED Lighting Upgrades

1. The Promoter is SSE Airtricity, which is a trading name of SSE Airtricity Limited which is a member of the SSE Group. The Registered Office of SSE Airtricity Limited is SSE Airtricity, Red Oak South, South County Business Park, Leopardstown, Dublin 18, Ireland D18 W688. Registered in the Republic of Ireland No. 317386 (The "Promoter").
2. The Supplier is Verde Energy Group, a trading name of Verde LED Limited. The Registered Office at Unit 4, Courtstown Industrial Estate, Little Island, Cork T45 R778. Registered in the Republic of Ireland No. 480361 (The "Supplier").
3. SSE Airtricity in partnership with Verde Energy Group are offering Lighting as a Service, with no upfront cost and full capital investment in LED lighting for businesses. Repayment for new LED lights paid for by the Customer in monthly or bimonthly (Max Demand meter only) instalments over an agreed term (the "Offer").
4. The Offer is available to Customers who enter into to a fixed repayment agreement with the Supplier for the upgrade of their lighting to LED lighting.

The Lighting as a Service ("LaaS") repayment schedule isn't dependent on a supply agreement being in place with SSE Airtricity:

- (a) If a Customer chooses to switch their energy supplier during the term of the agreement, the LaaS monthly invoices and repayments will continue with SSE Airtricity for the remainder of the agreement until the lighting upgrade costs have been repaid.
 - (b) Customers will also have the option to finalise their LaaS agreement at time of switch of supplier by settling the remaining outstanding LaaS balance with Verde Energy Group.
5. This Offer is subject to passing credit checks, availability, suitability and geographical restrictions. While the vast majority of businesses are suitable, there are a small percentage that are not.
 6. The Promoter will act as a collecting agent for the Offer, the Customer will be contracted with the Supplier for the value of the lighting upgrade works.
 7. Please note that this offer applies to Business Energy Customers in the Republic of Ireland only, and eligibility will be determined by Verde Energy Group suitability checks.
 8. These terms are in addition to: a. General Terms and Conditions for LaaS by SSE Airtricity Limited (which can be found in Your Welcome letter pack, Your original marketing email and/or Our website at www.sseairtricity.com) b. Verde Energy Group 's Lighting as a Service Terms and Conditions for business premises ("Verde Energy Group LaaS Terms & Conditions" which can be found on their website at <https://verdeenergygroup.com/terms-and-conditions/>).
 9. The price for the Offer is as set out in your Customer Agreement with the Supplier and the Welcome letter repayment schedule from the Promoter, and are to be paid in line with the following conditions:
 - a. Having the cost of the Offer and any Supplement Costs charged to Your SSE Airtricity bill (subject to a LED lighting installation and satisfactory credit check);

- b. Paying for the Offer by monthly direct debit instalments (subject to a satisfactory credit check);
 - c. The supplier will ask for Your payment details at the same time that You book and You sign up for this Offer.
 - d. We will ask for You to verify the payment details at the time of the repayment schedule commencing for this Offer.
 - d. You must pay by way of direct debit, You can provide changes to Your direct debit instructions by telephone or in writing (by completing the Direct Debit Mandate attached to Your SSE Airtricity bill).
 - e. You may terminate the arrangement at any time cancelling the repayment schedule with SSE Airtricity and by paying the full outstanding amount payable for the Offer at that time to Verde Energy Group.
 - f. Should You miss a Direct Debit payment, SSE Airtricity will expect You to make contact to set up a payment arrangement for the overdue balance, failure to do so will result in overdue credit cycle commencing with reminder calls and letters being issued. Failure to fulfil Your obligation or to make the scheduled payments during the credit cycle will result in Your on-bill repayment schedule service being cancelled with SSE Airtricity. You will still be liable to Verde Energy Group for the remaining unpaid cost of the installation and the balance will be transferred to the Supplier to be paid in full by the Customer
 - g. Payments shall commence from the date of your first utility bill following completion of the lighting upgrade works, unless otherwise stated in the repayment details contained within Your SSE Airtricity Customer Welcome letter, and in line with the repayment agreement terms and conditions with the Supplier.
10. Upon expiration of the term, you will be sent a letter by the Promoter confirming that full repayment has been made and that monthly instalments will no longer be payable.
11. Once You have received an SSE Airtricity LaaS welcome letter, there is a 14-day cancellation period. There is no penalty for cancelling LaaS repayment agreement during the cancellation period. However, You will still be liable to Verde Energy Group for the full cost of the installation and the amount due will be transferred to the Supplier to be paid in full by the Customer.
12. Should You wish to cancel Your repayment arrangement and You have availed of the Offer You must give 30 days' notice and SSE Airtricity will cancel your repayment schedule on your supply account. You will still be liable to Verde Energy Group for the remaining unpaid cost of the installation and the balance will be transferred back to the Supplier to be paid in full by the Customer.
13. There is no Cash alternative to this Offer.
14. This Offer cannot be used in conjunction with any other offer.
15. SSE Airtricity reserves the right to amend or cancel this Offer at any time.
16. Full terms & conditions are available by contacting SSE Airtricity Business Energy Customer Service on 0818 81 21 44 to request or will be included within the SSE Airtricity Welcome letter.

17. SSE Airtricity reserves the right to set-off any payment from You against fees owing in connection with your energy supply bill where applicable. Once your energy supply bill has been satisfied, the remaining monies shall go towards any amount owed on the LaaS agreement.

18. SSE Airtricity reserves the right to amend these Terms and Conditions at any time without prior notice to You. Any amendments to these Terms and Conditions shall be available as soon as practicable after the change or amendment has taken place on our website www.sseairtricity.com

20. SSE Airtricity does not warrant the quality, fitness for purpose or condition of the LED Lighting products. Warranty, fitness for purpose or conditions shall be covered by the LED Lighting products manufacturer's terms and conditions which are available at www.verdeled.com/terms-conditions/

21. Verde Energy Groups installers will assume responsibility for supplying, fitting, installing and setting up of the LED lighting products at your premises. Verde Energy Group's installers will assume responsibility for maintenance and any replacement of the LED lighting products at your premises, as per the Terms & Conditions of Verde Energy Group's maintenance agreement with You. Should there be any delay in the supply and/ or installation of replacement fittings during the warranty period, the Customer is obliged to continue to make monthly repayments in line with the agreement.

22. To the maximum extent permitted by law, SSE Airtricity shall not be liable for any loss, damage, injury or claims howsoever arising in contract, tort or otherwise out of the installation or use of the LED Lighting products. In particular, SSE Airtricity shall not be liable for any direct, indirect, incidental, special or consequential loss or damage arising out of the installation or use of the LED Lighting products and, furthermore, shall not be responsible for any personal injury or property damage resulting from the handling, possessing, installation or use of the LED Lighting products.

Energy Credits:

23. It is possible that you may be eligible for an Energy Credit discount (subject to the conditions and approval of SEAI under Energy Efficiency Obligation Scheme). "Energy Credit" means the measured or derived reduction in primary energy consumption as (measured in kWh) and as certified by the SEAI following relevant monitoring and verification to the relevant standards as defined by the SEAI.
